No additional nominations were made from the floor. Votes were cast and ballots then collected. Votes will be tallied and reported by the close of the annual meeting.

BOYEM Report: Clint Mack. Other board members are Erik Aamlid, Jess Felten, Alan Strand & Danielle Tieben. BOYEM manages Hope's youth education programming.

Highlights of 2022: 68 children attended VBS, 32 youth are in confirmation and H2H, 4 children attended Green Lake Bible Camp, 37 children and numerous volunteers are involved with Kids of the Kingdom Sunday programming, 6 youth went on the mission trip to Milwaukee, WI. VBS participation continues to grow and we are looking for ways to continue and enhance programming. We brought 5th grade students into the H2H curriculum and will be assessing that after the school year is completed. Additional volunteers are always needed. KOK programs are being adjusted to better match the weekly worship service lessons. We are looking into new mission trips / opportunities that include more of an adventure component. Thanks to Pastor Ted and Pastor Steve for their fine work planning and leading confirmation classes. Welcome Leah Aamlid, Justin Kempf & Hope Mack to the board!

Deacons Report: Jason Felten. Other board members are Deb Barker, Paul Engfer, Kathy Mattson and Shelli Schubert. The Deacons are responsible for the spiritual health of the congregation, organizing and encouraging opportunities for people to grow in relationship with each other. The easing of Covid restrictions and people returning to church allowed us to renew some existing fellowship opportunities and begin some new ones.

2022 Highlights: During the Christmas season we brought in donations of \$2,100 for ELCA Good Gifts, in April we raised \$1,280 for the MN food share drive, in May we teamed with KOK to provide carnations in celebration of Mother's Day, while in June we had a bowling event in which 23 bowlers participated in raising \$300 for the local food shelf and we celebrated Father's Day with root beer floats. In August we kicked off the monthly movie night that involves 20+ volunteers and through December has raised \$260. In September we partnered with BOYEM in the 2nd annual Welcome Sunday event. November featured the return of the chili cook-off. We are always looking for new and creative ways for fellowship so feel free to bring us any suggestions you may have. Special thanks to Angie and Sarah for their continued support in all we do.

Trustee Report: John Tieben Sr. Other Trustees are Roger Anderson, Rod Lieske, Ben Kalow and Kelly Lorenz. Trustees oversee the budget, building, facilities, grounds and maintenance inside and out, as well as the usage of the facility. See page 11 of the annual report for the full list of projects. We rely on many volunteers to accomplish these tasks and give thanks for all of them. Thanks to Rod Lieske and Roger Anderson as their terms expire, and welcome to Steve and Brad (if they get elected).

Stewardship Committee Report: Dave Holzer.

Our theme this year is "Blessed to be a Blessing", the sharing of what we have. Stewardship report is written. We encourage everyone to complete an estimated giving card and to take advantage of the electronic giving program currently in place. Thanks to everyone for your participation in the stewardship drive and for your continued support of Hope Lutheran.

Mortgage Payoff Celebration: John Tieben Sr and Doug Hvidsten (to the theme song from "Rocky"). Thank you to Dave Holzer and Hometown Bank for your faith and investment in us years ago when our current facility was built and for working with us along the way. A symbolic check for \$1,530,000 was presented to Dave. Per John, we chose not to burn the mortgage as the building was just paid for. Denny added our thanks to Pastor Steve for his leadership through most of the mortgage years.

Transition Team update: Doug Hvidsten. Other members are Molly Warmka, Clint Mack, John Tieben Jr, Erik Aamlid, Dave Holzer, Deb Anderson, and Pastor Ted as our guide. Our goal over the past 6 months has been to make good choices in determining the characteristics we want in our new pastor. We are half-way through the projected timeline and at least that far in the overall process. We recently completed the step of ID'ing our top priorities. A visual representation of that is posted in the narthex. We've now begun working on the Ministry Site Profile which creates for prospective candidates an accurate picture of Jordan, of Hope Lutheran and of our wants and expectations. We plan to complete the MSP in the March / April timeframe. Following the Synod's review and approval, we can then launch the actual call process.

Call Committee process update: Lanae McClellan.

Call Committee member selection process is planned for the March council meeting. Hope's constitution requires that no less than 6 members comprise this committee. Once the MSP has been approved by the Synod, this process can begin. Please ask yourself if you have the interest and time to be considered for this vital task.

50th **Anniversary Committee Report:** Brenda Lieske. Other members are Char Senske, Harry Janssen, Kathy Templin, Sally Voss, Lynn Mollenhauer, Glenda Laffen, Danielle Tieben, Alexi Zimmerman, Kathy Mattson, Kyle Narum & Sarah Gavert. We have selected Sunday, September 10, 2023 as that is 50 years after the initial worship service and it coincides with this year's Heimatfest celebration. Please bring to the committee members any suggestions you may have for making our 50th celebration successful.

Treasure's Report: Doug Hvidsten

The full financial report is listed in the annual report that is available for all members to read and study. Income was \$390K vs budget of \$412K (94.6%) Attendance and giving rebounds from the Covid era were a little slower than we estimated a year ago. Expenses totaled \$424K vs budget of \$412K (\$12K over). That included an unbudgeted payment of \$14K to zero-out the mortgage. Actual operational expenses came in at 99.5%. Thanks to the office staff and the Trustees for forecasting and managing expenses so well. We are in good financial condition. Now that the mortgage is paid off, we have plans to continue and grow the worship and education experiences at Hope, as well as maintain and improve our facilities. We ask for your continued financial support so that Hope Lutheran can continue to be a place where we can Gather, Grow, and Go!

Proposed Budget for 2023: John Tieben Sr

See page 15 of the financial report. 2023 expense budget is \$5K less than 2022. Now that the mortgage is gone, we have chosen to invest more in youth and education, fellowship and outreach, increased funds for bible camp scholarships, covering the meal costs for youth attending Wednesday evening programming, creating a place-holder for a potential youth minister, and setting up a capital reserve for necessary repairs to the parking lot and building. The reserve's purpose is to allow us to be proactive in providing funds for such expenses rather than doing a capital campaign and loan when we do move forward with any of these. The full financial report is listed in the annual report that is available for all members to read and study.

The proposed budget prepares a path for the continued success of Hope Lutheran as we move into the next 50 years. A motion to approve the proposed 2023 budget was made, seconded and approved. Checks are created using Shepherd Staff's software

Angie signs, mails, and distributes checks

Purchase order, receipt and check stub are placed in a folder for Trustees

Trustees review monthly payments

Documents are filed

Dual control of weekly offering collection has been implemented

Reconciliation of bank statements is performed by Treasurer

Board of Youth and Educational Ministries

The Board of Youth and Educational Ministry (BOYEM) is tasked to provide, plan, promote and oversee the faith formation and educational programs of the congregation. This includes both youth and adult ministries. The strength of these programs is only made possible because of the many dedicated and skilled volunteers that help support these ministries.

There are 32 children enrolled in Kids of the Kingdom (KOK) which provides education to 4 yr. olds through 4th graders on Sundays after the worship service. KOK relies on many volunteers who assist with music, teaching, and preparing lessons. The KOK volunteers planned lessons to coincide with the worship services lesson and organized other fun events. We hosted our 16th annual Operation Christmas Child where youth packed 158 boxes. Offerings from KOK children are being donated to the ELCA Good Gifts project.

We continue to host "Keeping the Promise" family retreats that help parents fulfill the promise they made when their children were baptized. Retreats led by our pastor were provided for grades 1 through 5 on the Lord's Prayer, 10 Commandments, Bible, Apostle's Creed, and Holy Communion.

We have a group of 34 Head to Heart (H2H) confirmation youth that fill this place with energy Wednesday evenings. Pastor Matt leads the lessons and volunteer group leaders work together to create a fun environment with learning, fellowship, and service. We have worked to incorporate more fellowship and service events into the schedule this year. Some of our service events include: setting up for Operation Christmas Child and the Sandwich project. To work in some fun fellowship, we have gone mini golfing and enjoyed some fun game nights - not to mention the weekly pizza dinners! Ten youth were confirmed in 2023.

In addition to programs that serve children during the school year, Hope Lutheran coordinates and encourages youth to participate in fun faith building summer opportunities. A wonderful team of coordinators and adult and youth volunteers supported our Vacation Bible School (VBS) program in which 69 children participated. A show of the quality of this program is that it attracts and serves many children from the community. We also had 5 children attend Bible Camp. We are appreciative of the donation from the Lindell Family which continues to offset some of the costs for these faith formation activities. In addition, Hope Lutheran also kicks in a stipend amount for each camper. In our mission to help make camp affordable for all families, we also offer camp scholarships.

Board of Youth and Educational Ministries cont. . .

We have initiated and participated in a variety of activities and events to help impact all congregation members. One event was a summer fellowship gathering where individuals and families were invited to participate in outdoor games, a meal, and fellowship. We also assist the deacons in the monthly movie nights. We helped coordinate a float in the Heimatfest Parade to share our programs and invite the community to Hope Lutheran. We had some high school youth assist in putting together care packages for last year's senior class, as well as care packages for our homebound members. BOYEM members and Pastor Matt delivered the care packages to homebound members.

One of our biggest goals and accomplishments this past year was the renovation of the Youth Room. The room received a fresh coat of paint, furniture updates, and new flooring. There were many volunteers that donated items, their time, and talents into helping BOYEM update this room. The room has been a huge success, especially on Wednesday evenings for youth!

For adult education, the Adult Bible Study has remained strong. We have been working closely with Pastor Matt and are excited for continued Adult Education opportunities in the new year.

The current BOYEM members include Leah Aamlid, Jess Felten, Hope Mack, Alan Strand, and Dustin Kempf. The BOYEM members want to again thank all the volunteers. We also want to thank Hope's office staff who help provide significant support and Pastor Matt who has participated in and guided these programs this year.

BOYEM members, youth, and their families have put a lot of time and effort into these programs. Thank you to all who have supported these programs this year.

Nobel 60 — Sleep Unraveled brings together an interdisciplinary panel of experts to explore the centrality of sleep for human health and mental well-being. In addition to its role in physical rejuvenation, sufficient high-quality sleep is crucial for cognition, memory, learning, and general health. Sleep loss — whether triggered by noise or light pollution, stress, overwork or conflict with circadian rhythms — has been associated with high blood pressure, weight gain, diabetes and a plethora of other medical conditions. The conference will also delve into the neurological and psychological processes of sleep, the cultural evolution of sleep practices and the social justice implications of a twenty-four hour convenience society that condemns workers to permanent sleep deprivation. Bishop's Annual Report to Congregations

Grace, peace, and hope through our Savior, Jesus Christ.

In May, we meet for our 2024 Synod Assembly under the theme "With Glad and Generous Hearts." The phrase describes the early church as they gathered on Pentecost. It is also an appropriate description of the past year of our life and ministry together.

In 2023, our hearts were gladdened by:

- Your congregation, along with the other 136 congregations in our synod, faithfully proclaiming the Gospel of Jesus Christ in Word and Sacrament, nurturing community, and loving neighbors and neighborhoods.
- The privilege of accompanying congregations in 72 Call Processes; presiding at 14 Ordinations and 30 Installations; and walking with 34 people preparing to become pastors or deacons.
- 142 lay leaders and 28 clergy from 31 congregations learning to be church in the 21st century through our Faith Practices and Neighboring Practices intensive learning communities.
- 6,500 people receiving our weekly enews. (Sign up at mpls-synod.org/sign-up to feel more connected.)
- 100s of rostered and lay leaders involved in synod sponsored peer groups, conferences, and retreats.
- 100s of leaders from synod congregations helping pass the state's "100% Clean Energy By 2040" and "Restore The Vote" legislation that advance both climate justice and racial justice.
- 100s of leaders faithfully serving as Deans, on Synod Council, and Candidacy, Audit, Program Committees.
- 15 gifted and devoted synod staff members: 10 funded by Mission Support from you and other congregations, and 5 funded by Lilly Endowment and other external grants.

We praise God for the congregational generosity that makes all this happen. At the same time, we recognize that mission support from congregations has declined 16% over the past 10 years, resulting in a reduction in synod staff hours. Especially as we prepare to elect a new bishop this spring, we invite you to consider strengthening your support for the future of the synod's work.

Conference Assemblies are just around the corner: Saturday, February 10, 9:30 a.m. – Noon. Of particular importance will be conference nominations for bishop as well as for voting members to the ELCA Churchwide Assembly, July 28 - August 2, 2025. We encourage congregations to send the same voting members to both the Conference and Synod Assemblies.

As we look at declining mission support or grieve the closing of a congregation, we can become discouraged. In such moments, I encourage you to listen to a remarkable conversation from our 2023 Synod Assembly. Our keynote speaker, the Rev. Otis Moss III, was asked: "what do you say to those who think the church is dying?" Filled with courage and hope, Moss responded, "the church is not dying, it is being born, refashioned, and remade. The early church was an alternative community. Today we use the metrics of the market to evaluate the church – buildings, budgets, numbers. But, the early church looked at *impact*: were people hearing the good news of Jesus who lived and died for our salvation? Was suffering being relieved? Were people being welcomed and healed?" Rev. Moss reminds us that we are called to be alternative communities. What might it take to measure our churches by *impact*? The work of synod leadership is to support the 137 communities and the thousands of leaders who are making an *impactful* difference in the 21st century: sharing the good news of Jesus, extending radical welcome into beloved community, engaging their neighborhoods in love with justice.

I am filled with both gratitude and sadness as I write this, my final annual report to congregations. I have loved serving as your bishop and am profoundly grateful for this calling. We pray for the year ahead, trusting in the goodness and faithfulness of our God, made known in Jesus Christ.
