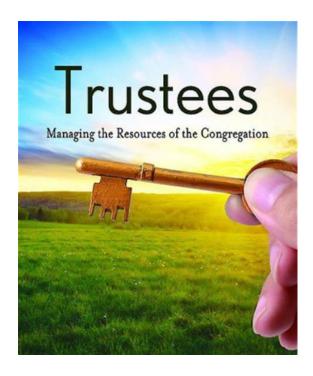

Audit Committee Report

OBJECTIVE:

The objectives of this financial audit are:

- To review financial records and procedures for safe, secure and efficient practices
- To provide Board of Trustees with recommendations that would enhance the church's financial program and prevent fraud

PROCEDURES OF AUDIT:

The following procedures were used to determine if the audit objectives were met:

- 1. Discussion with church office manager, Angie Newton
- 2. Reviewed monthly bank statements
- Reviewed Shepherd Staff's accounting software monthly reconciliation documents
- 4. Reviewed monthly board reports for consistency to bank statements and Shepherd Staff internal monthly reports
- 5. Reviewed purchase orders over \$2500

PROCEDURES OF OFFICE MANAGER:

The outline of the process for financial transactions is as follows:

- Angie Newton receives receipts for reimbursements or bills to be paid
- A purchase order is created in Shepherd's Staff's software for each check (purchase orders \$2,500 or above need two trustees signatures prior to purchase)
- Checks are created using Shepherd Staff's software
- Angie signs, mails, and distributes checks
- Purchase order, receipt and check stub are placed in a folder for Trustees
- Trustees review monthly payments
- · Documents are filed
- Dual control of weekly offering collection has been implemented
- Reconciliation of bank statements is performed by Treasurer

Audit Committee Report cont. . . .

FINDINGS:

 Missing individual bank deposit receipts. We were able to reconcile deposits in Shepherd's staff to the bank statement and bank copies of deposit slips.

RECOMMENDATIONS IMPLEMENTED SINCE LAST AUDIT:

- "Other Offerings" added as a category in Shepherd's staff.
- Treasurer began signing and dating bank statements after reconciliation to Shepherd's Staff was completed
- Audit Committee reviewed a full calendar year (2024)

FUTURE RECOMMENDATIONS:

- Continue procedures of Office Manager as stated above
- Encourage timeliness of purchases to prior approval of Trustees as needed.
 Recommended Angie send a weekly calendar reminder to trustees to sign purchases on Sundays.
- Recommend Treasurer more consistently sign and date bank statement after reconciliation to Shepherd's Staff.
- Recommend generating a vendor report in Shepherd's staff to verify 1099s that need to be created/mailed (vendors/people that have been paid over \$600 for the fiscal year).

- Recommend any items/paperwork containing personal information be locked, covered, or password protected.



Taco Stand Report

2024 brought another profitable year for the Hope Lutheran Taco Stand. Due to continued rising food costs, we made the decision to update our menu pricing this year. With relatively even sales compared to previous year, that allowed us to increase our operating profit by just over 13%. Board of Youth and Educational Ministries

The Board of Youth and Educational Ministry (BOYEM) is tasked to work alongside the Directors of Children's and Youth Ministry to provide, plan, promote and oversee the faith formation and educational programs of the congregation. In addition, BOYEM supports and enhances adult education opportunities. The strength of these programs is made possible with the help of many dedicated and skilled volunteers that support these programs. This year has seen an incredible energy boost with the hiring of the new Directors of Children's and Youth Ministry positions. They've incorporated many new events, kept our congregation informed, and stirred up excitement in just about everyone!

There are 42 children enrolled in Kids of the Kingdom (KOK) which provides education to 4 yr. olds through 4th graders on Sundays after the worship service. This is a special time for children to connect and grow in their faith! A faithful group of leaders continue to share the love of Jesus each week. Offerings collected at KOK and by the 'noisy offering' are being donated to various local organizations. Children and their families have served together at Feed My Starving Children, the November Welcome Table, making tags for fleece blankets, packing boxes for Operation Christmas Child, and creating birthday cake kits to be donated to the Jordan Food Shelf. They have also enjoyed opportunities to connect through the Family Easter and Christmas Celebrations.

We have a group of 39 Head to Heart (H2H) Confirmation youth that fill this place with energy Wednesday evenings. Pastor Matt leads the lessons and volunteer group leaders work together to create a fun environment with learning, fellowship, and service. Some of our service events included Operation Christmas Child, Welcome Table, making blankets, participating in Feed My Starving Children, Bags of Smiles, and the Sandwich Project. To work in some fun fellowship, we have also had a movie night, gone ice skating, went caroling, participated in a Thanksgiving Bible scavenger hunt, and had a Fear Factor night not to mention the weekly pizza dinners! Six youth were confirmed in the Fall of 2024.

Board of Youth and Educational Ministries cont. . .

The HSM, High School Ministry, youth group has been revitalized this year! This group offers fun activities and service opportunities for our young adults after they have been confirmed. Not having a high school ministry for a few years, it has been fun to see this group start up! About five attend this program, and we hope to continue growing excitement over the years. A few highlights from this year include a weekly "Dose of Hope" devotional time, making care packages for last year's senior class and homebound members, Fear Factor night, and seeing relationships grow amongst the youth each week.

In addition to programs that serve children and youth during the school year, Hope Lutheran coordinates and encourages participation in fun faith-building summer opportunities. A wonderful team of coordinators, along with adult and youth volunteers supported our Vacation Bible School (VBS) program in which 50 children participated. A show of the quality of this program is that it attracts and serves many children from the community. We also had ten children attend Bible Camp. We are appreciative of the donation from the Lindell Family which continues to offset some of the costs for these faith formation activities. Hope Lutheran also provides a stipend amount for each camper. In our mission to help make camp affordable for all families, we also offer camp scholarships.

The CYF (Child, Youth, and Family Ministry) Team coordinated monthly events for families to participate in such as tailgating, Feed My Starving Children, community Welcome Table meal and service, caroling, and sledding. These events provide opportunities for families to connect with one another and strengthen faith-filled relationships.

"Keeping the Promise" family retreats are held throughout the year. These retreats help parents/guardians fulfill the promises they made when their children were baptized. Retreats were provided for grades 1 through 5 on the Lord's Prayer, the Bible, the Ten Commandments, the Apostles' Creed, and Holy Communion. A Confirmation retreat for 9th graders took place prior to their Affirmation of Baptism. Children and youth now receive a faith milestone for each of these retreats to serve as a tangible reminder of these promises. Children and youth are recognized at worship where they receive these faith milestones.

For adult education, the Adult Bible Study has remained strong. The 'Life Group' met onsite as well as at some local establishments and has provided a wonderful opportunity to form relationships between attendees. Pastor Matt led a 5 week 'What About' discussion that was well attended, and a 2nd session is planned to begin in February. During Lent, we implemented a mentor program which paired up an adult from the congregation with each of our 8th grade H2H students.

The 2024 BOYEM members included Leah Aamlid, Jess Felten, Hope Mack, Derek Staloch, and Alan Strand. BOYEM members, along with the Directors of Children's and Youth Ministry (Danielle Tieben, Erik Aamlid, Leah Aamlid) would like to thank the office staff who help provide significant support, the council for approving an ample budget, and Pastor Matt who has participated in and guided these programs this year. Thank you to all who have supported these programs!

Bishop's Annual Report to Congregations

Grace and peace to you, beloved of Christ Jesus.

This resurrection story is a favorite. We walk together as church, and Jesus draws near and walks with us. The labors of the day, the content of our discussions, the swirl of society and politics, the hopes and fears, these things shift, and yet, Jesus walks with us and is known once again as we gather together around the table.

What a year this has been. This report to the worshipping communities of the Minneapolis Area Synod is an opportunity to look back on 2024, and to look ahead at the year to come. Most of all, it is an opportunity to name and celebrate some of the ways the Holy Spirit continues to enliven God's church. We give thanks to you and your congregation for your partnership in this ministry we share.

On May 4, 2024, you elected me to serve as your Bishop. On August 1, 2024, I took office, and on September 21, 2024, I was installed during a festive and moving worship service at Central Lutheran Church. This election represents a significant threshold in our synod's life as we continue by the Spirit's leading along paths yet unknown. Thank you for your trust and your continued prayers. We are particularly grateful for the intentional work of the Bishop's Election Committee. My deep thanks to Bishop Ann Svennungsen for her 12 years of faithful leadership, and for her generosity of wisdom and spirit as I learn the ropes. As I have restructured parts of our synod's ministry team, we have had several staff transitions. Some have completed their service, over the summer and fall we welcomed a few new staff, and in 2025 we will welcome more. Thank you to our staff for their patience, perseverance, faithful ministry, and good courage during a long transition.

Stepping into this role, I am more mindful than ever that we are **Church Together:** Learning Together, Listening Together, Serving Together, Worshipping Together

A few highlights from 2024:

- 137 worshipping communities, including
 - 3 new starts congregational
 - 8 strategic ministries
- 3 congregations marked Holy Closures this year, honoring their years and ministry, and in closing, stewarded their assets by contributing to the Resurrection Fund.
- 11 languages spoken in worship
- 62 call processes in 55 congregations
- 8 ordinations of new pastors and deacons and
- 24 rostered ministers installed into new positions
- 34 people discerning a call to ministry and active in our candidacy process
- 305 pastors and deacons currently serving in our synod, and around 370 retired ministers
- 52 pastors and deacons serving in specialized ministries, including chaplains, educators, social ministry leaders, and
- 5 years of Faith Practices and Neighboring Practices cohorts supported by a grant from the Lilly Endowment's Thriving Congregations Initiative, with plans to apply for a scaling grant in 2025
- 17 congregations in the current cohort of Faith Practices and Neighboring Practices, and
- 13 in the first cohort (that's nearly 1/4 of our synod's congregations!)
- \$1.25 million grant received from the Lilly Endowment for Family Faith a project accompanying parents and caretakers from the Synod's new and strategic ministries. Watch for more details coming soon!
- 800 people attended the Bishop Installation in person, including 220 clergy
- \$2,681,409 pledged in Mission Support, with 50% supporting MAS ministry and 50% for ELCA ministry
- 2 companion synod partnerships: Lutheran Church of Christ in Nigeria (LCCN) and the Leipzig District-Evangelical Lutheran Church in Saxony, Germany, including visits from Archbishop Musa Filibus (LCCN), Superintendent Sebastian Feydt and Pastor Cristoph Reichl (Leipzig)
- Synod staff supported leaders and congregations, convening, communicating, collaborating, and navigating conflicts
- Hosted many special events such as an Eco Faith Summit, Boundaries Workshop, Bishop's Theological Conference, Ministeriums, and Communicators Gatherings

What a gift to reflect on the amazing ways we were Church Together in 2024! We look forward to 2025 with the Conference Assemblies in February, Synod Assembly (May 2 - 3), and the ELCA Churchwide Assembly (July 28 - August 2). We walk together as church, trusting that Jesus continues to come near and walk with us. We are Church Together.
